# **Eastport Yacht Club Marina Rules**

#### **General Rules:**

- No grill or any other source of open flames may be used on any boat in the marina or on any dock or pier. The use of a permanently installed galley stove is permitted on an attended boat.
- No crabbing fishing or swimming in marina waters
- No painting, covering or altering any marina structures except in accordance with current marina policies or with the permission of the Marina Committee.
- EYC is a "Clean Marina": Place refuse in designated trash containers; cleaning or painting activities on the yard are to be done in an environmentally responsible manner
- No children under the age of 12 on the docks unless accompanied by an adult. Use of PFDs by children is encouraged.
- Owners must supervise their pets by keeping them on a leash and cleaning up after them
- Live-aboards and paying guests are not permitted. Slip holders, guests and transients may stay on board their boats overnight at their assigned dockage for not more than 7 consecutive days nor more than 12 total days per month.
- Docking at the T end of the floating B Dock is strictly prohibited.
- Members must be familiar with all current EYC Policies regarding use of the Marina
- All rules are to be followed by Members and guests as posted in the marina.
- All boats and trailers must be identified by name or membership number. Transients must be registered with the Waterfront Director.
- Dinghy dock is for temporary use only. Dinghies tied up in the marina for more than 24 hours without Waterfront Director or Marina Committee approval are subject to removal at the owner's expense.

# **Eastport Yacht Club Marina Rules**

#### **Trailer Crane and Tractor Rules:**

- Crane and Tractor use is limited to Marina Tenants that are qualified and Non-Marina Tenants that have signed a liability waiver, or with the approval of the Club Office, Marina Committee Chair or, in their absence, a designee.
- The crane will be locked and tied off when not in use. The last person to launch or haul is asked to secure the hoist and cover the tractor.
- Slipholder trailers must be parked in designated spaces
- Parking shall not obstruct access to the crane, docks, or other boats

### **Transient Rules:**

- Use of docks, mooring, or dry storage space without prior approval is limited to 20 minutes
- All transient docking arrangements, must be made with the EYC Waterfront Manager and subject to transient fees
- Transient use is limited to the outside of A and C Docks
- Use of B dock is limited to member boats 26 feet or less, for 2 hours or less, and not within 100 feet of the Crane. Members must sign in at the bar.
- Use of the docks and facilities must not impede the use and enjoyment of the facilities by other slipholders.

### **Golden Rule:**

- Courtesy and congeniality above all
- Everyone using the marina shall show consideration for the rights and comfort of other Members and their guests. Guests and transients (including visiting yachtsmen from other clubs) are requested not to disturb docking lines, hoses, fenders, power lines, or other items belonging to permanent slip holders.
